Annual General Meeting of Cole Harbour Woodside United Church Sunday, March 3, 2024 10:30 a.m. MINUTES

Jane Parmiter, Chair of the Unified Board, constituted the meeting in the name of Jesus Christ.

Voting Privileges for Adherents: Moved by John Siteman, seconded by Susanna Morash-Kent, that adherents of our congregation who are not full members be permitted voting privileges in this meeting. Carried.

Acceptance of Agenda: Moved by Roger Kent, seconded by Anne Marie Siteman, that the agenda be accepted as circulated. Carried.

Adoption of Minutes – February 2023: Moved by Margaret Crowell, seconded by Juris Svistunenko, that the minutes be adopted as circulated.

Lee Ayer asked for the following corrections:

Under Dinner Theatre – The Cast, it should read Brock McNamara
Under UCW Annual Report – Social Committee, the name should read Lee Ayer

Under CHWUC – UCW Fund, the text should read "balance as at December 31, 2023" Motion carried, with corrections noted.

Remembering Those We Lost in 2023: Jane Parmiter read the list of names of members of the congregation who died in 2023.

Celebrating Our Life and Work Together in 2023:

- Jane expressed her gratitude to the many people who work so hard for the Unified Board.
- Roger Kent, President of the Choir, expressed the gratitude of choir members for the direction of Charles Myra. Roger also thanked Greg Myra for his help and Lee Ayer for her work as Treasurer of the Choir.
- Joann Chapman celebrated the success of dinner theatre and the tremendous work by Jill Brogan, all the cast members, members of the band, and the volunteers in the kitchen.
- Lee Ayer thanked members of the congregation for buying grocery store gift cards, which netted the church \$32,000 over sixteen years. She especially thanked Marylou Foster for her dedication in selling the cards.
- Janet Barker expressed her thanks to the technical crew who serve at every service and throughout dinner theatre.
- Jill Brogan expressed her thanks for the volunteers who help with dinner theatre and all our other many fundraising efforts.

Annual Reports and Financial Statements: Co-Treasurer Shirley Clouter moved to accept the Annual Reports and Financial statements as printed. Seconded by Lee Ayer. Motion carried.

Pastoral Charge Mission & Service Goal: Cyndy Barclay-Hill reported on Mission and Service givings to the national church over the past year. National givings in 2023 totaled \$20,831,564. This amount marks a small decrease over 2022 givings. She expressed her heartfelt gratitude to the CHWUC congregation for our givings, which totaled a little over \$15,000.

Shirley Clouter moved acceptance of our pastoral charge goal for 2024 of \$14,500. Seconded by Roger Kent. Motion carried.

Pastoral Charge Budget: Shirley Clouter moved that the budget for 2024 be accepted. Seconded by Gordon Parsons. Motion carried.

Jane Parmiter expressed the congregation's gratitude to Shirley Clouter and Bob Wight for their great dedication as our Co-Treasurers.

Cole Harbour Cares: Anne Woods reported to the congregation on the recent history of our refugee sponsorship efforts and moved that Cole Harbour Cares be disbanded, effective March 2024. Seconded by Joanne Donaldson. Rev. Michael Mugford commented on the unique nature of this outreach program, pointing out that it not only succeeded in settling two Syrian families in Nova Scotia, but it also embraced other denominations and community members outside the church. He called Cole Harbour Cares a rousing success. Motion carried.

Anne Woods explained that Cole Harbour Cares had to decide what to do with its remaining funds. She told the congregation about three organizations - Open Harbour Refugee Association of Halifax, the Rainbow Refugee Association of Nova Scotia and the Hants East Assisting Refugee Team (HEART) – to which Cole Harbour Cares proposes giving its funds. Anne moved that Cole Harbour Cares funds be disbursed equally among Open Harbour Refugee Association, the Rainbow Refugee Association of Nova Scotia and HEART (Hants East Assisting Refugee Team) effective March 2024. She added that each organization will receive \$11,800. Motion seconded by Margaret Crowell. Motion carried.

Nominating Committee Report and Additional Nominations:

Jane Parmiter read the following corrections to the nominating report on pp 29 – 32 of the Annual Report:

Finance Committee:

Joann Chapman – term extended to 2025 Ian Short – term extended to 2026

Unified Board:

Add the following names as Members at Large: Juris Svistunenko, Anne Woods, and Linda Stonehouse, all with terms to 2026.

Jane pointed out that we still need some positions filled:

- The Affirming Committee needs a Chair, and it would be helpful to have an Affirming Committee member representative on Unified Board.
- CHWUC needs two representatives to Region 15.

• Stewardship Committee: Jane said that this is our biggest need to ensure our success going forward.

Jane made three calls for nominations from the floor for any of the positions named. Hearing none, Jane thanked everyone named in this report for their ongoing contributions to the work of CHWUC.

Ron Barker moved the acceptance of the Nominating Committee Report, as corrected by Jane. Seconded by Susan Grant. Motion carried.

Rev. Michael Mugford invited all members of our committees to stand and partake, with Jane Parmiter, in the dedication of all of our congregational ministers.

Dreaming for the Future: Joann Chapman, chair of the Visioning Committee, invited the congregation to express our dreams for the future of our church.

- Jane Parmiter introduced the idea of a Memory Café to be hosted in our hall to provide socialization for individuals experiencing memory problems and their caregivers. Jane explained that it is usually held a few times/year and involves offering music, snacks and social time. Jill Brogan suggested that grants might be available to help establish a Memory Cafe. Jill expressed her wholehearted support for such an endeavour and explained that other regions of the province host such a café, but that there isn't one in HRM yet.
- Joann Chapman shared her dream for CHWUC that we reach out to our Mi'kmaq neighbours in an effort to develop a relationship that honours treaty. She would like to see members of CHWUC make a pilgrimage, literally to walk, to the Caldwell Road band in an expression of peace and friendship.
- Roger Kent reminded the congregation that last year he had expressed his wish for an initiative that would help our church stay in touch with our younger members after they graduate from secondary school. He suggested that we open our hall to youth once a week for youth to gather, perhaps for dancing and non-alcoholic beverages.

Joann asked that any congregation member who didn't speak up, but who has a big dream for our church, to speak to her.

Motion to Adjourn: Randy Settle moved, seconded by Susanna Morash Kent, that we adjourn.

Church In a Pub Men's Group

The group consisted of eight men from the congregation meeting either at a local pub or one of our homes. In 2024 the group met on the last Tuesday or Wednesday of the month from January to June and September to November depending on member's availability. The summer months and Christmas were taken off from meeting.

The meetings followed a similar theme each month except September when we met at Big Leagues to kick off the new season and plan the coming meetings. When the meetings were held in a member's home, the host provided food and drinks that met the theme of the month. The meetings were led by Rev. Michael and his wonderful book: PAIRINGS: THE BIBLE AND BOOZE, by Matthew Anderson, who lives in Nova Scotia.

This book pairs stories from the Bible with both alcoholic and non-alcoholic drinks. These have included, but not been limited to, apple cider, wines, beer, and martinis with stories from Genesis, the Book of Ruth, the Gospel of Matthew, and the Psalms. These stories are woven into how the drinks reflect the story and its meaning and how this ties into the present day. The discussions often evolve (devolve?) into discussions on current affairs, personal stories and journeys, and, depending on the home, a pool game has been known to break out with laughter and stories not related to the theme of the night.

Sunday School

The Sunday School is growing in terms of numbers. We are now using two classrooms and dividing by ages, younger and older students. We also have young adults participating, and older teens helping with the younger students. Many students volunteer to read the Call to Worship, during the church service. Our Outreach Project was to fill Blessing Bags with personal care items and warm socks, for the homeless encampments within the Dartmouth-Cole Harbour area. We also helped support the Food Bank, operating from our church. Some of this help involved supporting local schools by providing food hampers, for some students who required them, when not in school on weekends. During the summer months the students had an opportunity to learn a variety of art techniques from Sharon Stewart, a retired elementary school teacher. Our theme for the year was "God in Our World". This theme was explored and then developed into a collage that is now proudly displayed on the main wall in the church hall. Two students, Quinn and Cecily, planted spruce seedlings on church property in order to provide clean air and decrease risks associated with climate change. Many students participated in the Christmas Eve Pageant.

The teachers who worked with me, Donna Vinning and Naomi Aquino, worked tirelessly to support students' spiritual growth, and without their assistance, the Sunday School students would not have had such a meaningful experience within God's World".

We put on four, full roast beef dinner shows, one dress rehearsal, and one afternoon, dessert theatre show. We had a total audience of approximately 530 people and made a profit of over \$20,000!

Since we serve meatballs and rice for our dress rehearsal show, we once again decided to donate \$5.00 from every ticket we sold for dress rehearsal night to Hope Cottage. This equated to a total of \$315 for which they were most grateful. We intentionally limited our seating to just over 100 seats per night as not to overwhelm our kitchen crew and to allow for more room between tables. Tickets were \$45 per regular show and \$25 for dress rehearsal and dessert theatre. It was another success for CHWUC and all who participated. Each year we tweak our processes with various kitchen shifts and cleaning methods to make it a little easier for our many "willing workers".

Cole Harbour Woodside United Church is blessed to have such a large number of people who eagerly participate in our Annual Dinner Theatre productions. This includes our cast, our homegrown band, Southern Comfort, kitchen crew, techie, prop, set team and of course our audience. To everyone who donates their time and talent to this very large endeavor, I offer you a huge thank you. We couldn't put this event on you.

Finance Committee

Annual Report 2024

The Finance Committee continues to conduct regular monthly meetings and manage the congregational budget on behalf of the Unified Board, monitoring our revenue and expenses and supporting fundraising efforts.

2024 was another eventful and quite successful year. We are pleased to have contributions to the operating fund increase by about \$20,000 in 2024 mainly as a result of several very large one-time contributions from members of the congregation. Fundraising revenue was down slightly. Early in the year we discontinued the supermarket gift card program. We thank the congregation for its continued support to the church and Ministry to meet our monthly commitments through their continued support of the PAR program , envelopes and online donations We are pleased with fundraising efforts which continue to be well supported by the congregation, including the dinner theater, maple syrup, sales auctions held in person and online take out meals, cookie sales, and other events .

While we continue to address significant challenges to our finances, the SE were more than offset by the generosity of our congregation and supporters in 2024. We are looking forward with hope that the trend towards ever strengthening finances will continue in 2025 and beyond.

- 1. Our operating fund revenue for the year was up from \$240,000 to \$258,000 in 2024, mainly because of higher contributions. Our recent success with fundraising continued as well helping to get us closer to the conclusion of our Getting Back on Track campaign.
- 2. For the first time since before the pandemic, our operating revenue for the year exceeded our operating costs and the church achieved a surplus of \$ 17, 532.
- 3. We had another successful dinner theater fundraising event this year. This event raises about half of the amount we earn from fundraising each year. Our sincere thanks to Jill and the dinner theater team.
- 4. In 2024 we contributed \$ 14, 508 to the mission and service fund, which is about \$900 less than we contributed in 2023.
- 5. In the fall, we established an investment account at the Royal Bank so that we can now accept contributions in shares of companies traded on stock exchanges in addition to cash contributions. This is yet another way that we have made it easier to support our mission. We would not have achieved a surplus this year without this facility and we're very grateful for the support we have received through it.

- 6. We are aware of the burden that inflation has had on families in our community. Our food bank has grown by multiples to address this hunger, and we continue to host the community fridge, food pantry at our site as well. While we don't account for the value of all the food distributed the cash donations made on behalf of the food bank in 2024 more than doubled from the prior year which was a record in itself. We had donations of \$44, 534 and we dispersed\$19,159. We are making a real impact on our community and our food bank volunteers should be celebrated.
- 7. The annual operating costs declined by \$12,000 in 2024 to \$241,000. Most of the savings came from lower compensation. Our Minister donated some of his salary to help us achieve our operating surplus in 2024. This generosity saved us about \$5,000. These lower compensation costs are despite incurring about \$17,000 in payroll, taxes and penalties during the year in order to settle all our balances for the period from 2018 until 2021 with CRA. We are pleased to report that this process is now substantially complete, and we will not have this type of costs going forward.
- 8. We are very pleased to report that our financial reserves for the operating fund are finally at an adequate level to cover seasonal revenue and expense fluctuations. This is the first time that we've had adequate reserves in many years. Our sincere thanks for the support to achieve this goal. It is so much easier to manage our finances when we have sufficient cash on hand. However, this is not the end of our journey towards sustainable finances. It is certainly an important milestone.
- 9. We recently conducted a review of our mission and service remittances for the period 2018 to 2021 and found that about \$30,000 of our contributions during those years was not remitted to the National M&S Fund. This process is under the auspices of the Unified board and is ongoing.
- 10. During the year we did some housekeeping with respect to the memorial fund. We only account for funds received that include a direction from the contributor as to what the funds will be spent on, in the memorial fund otherwise amounts given in memory of friends and family are included as bequests in the operating fund.
- 11. Your ongoing support and donations are greatly appreciated. We encourage each and every member to prayerfully consider the ways in which we can financially support the ministry that happens in response to God's call in this place. We are grateful that we are able to meet in person and continue offering the care and comfort of Christ with those in our congregation and wider.

In the fall months, we saw our numbers increase to over 50 orders given out each Food Bank day. We also continue to support the Cole Harbour Community Fridge, Square Roots and the school weekend grocery bag program.

I would like to make a special thank you to Audrey Law. Throughout the years, Audrey has made an overwhelming contribution to the Food Bank. This started many years ago, when she hosted luncheons twice a year. The admission to the luncheon was a donation to the Food Bank. These were well attended and notorious events. After the luncheon, we would receive a call from Audrey and it would take two vehicles to transport the food collected back to the church. Audrey also spends countless hours picking up cans and bottles during her daily walks around Cole Harbour. Audrey will cash in the cans and bottles and save the money for the Food Bank. At Easter, we always receive a number of chocolate bunnies, donated from Audrey for distribution to the children.

Hope Cottage

Annual Report 2024

Another year at Hope Cottage begins with our thanks to all of our loyal volunteers who have supported this mission and made it such a success over the years. Sweet and sour meatballs with rice is still a favourite meal and much appreciated by all patrons. They call it "The Hope Cottage Special". To those who have cooked and/or provided rice for the meal, once again thank you.

Meals will be served on Thursdays and the dates for 2025 are:

February 6; April 17; June 26; October 16; December 18

Recipe for Sweet and Soup Meatballs:

Mix 2lbs of ground beef with grated onion, salt and pepper. Make small balls and place in baking dish. (You can also purchase premade meatballs and simply make the sauce)

Sauce - mix the following ingredients together:
1 can mushrooms (pieces and stems)
1 can drained pineapple chunks but save the juice
1 1/2 cups brown sugar

3/4 cup vinegar
1 tbsp. dry mustard
1-2 tbsp. corn starch

1 cup ketchup

3/4 cup liquid (pineapple juice and water if necessary)

Pour over the meatballs and bake at 350°F for approximately 1 hour.

A number of new members in the congregation have approached us to learn more about Hope Cottage and its beginnings. The following is a brief history from their site on how this ministry developed:

"55th Year"

Hope Cottage was started by Fr. Joe Mills on July 1, 1970. Fr. Mills, who was pastor of St. Patrick's at the time, noticed a growing number of homeless people, mostly men, knocking on his door for food and assistance. There were no soup kitchens in Halifax at the time that catered to the needs of people during the weekdays. Fr. Mills called a number of women asking them to prepare a meal which they would serve to the men. 34 people showed up on the first day.

Since then, this organization has grown into an institution which is entrenched in the social fabric of Halifax. It is most probably that when Father Mills started Hope Cottage, he expected (or maybe hoped) that this would be a short-term solution to a temporary problem. Now here we stand, in our 50th year of operation!

Hope Cottage, along with the Board, the Friends of Hope Cottage, are proud of the relationships we have built in the community over the years. And humbled by the generosity of our community that always steps up! Hope receives no government funding, all funds to run our operations are raised through donations, fundraisers, sponsorships and our church groups who usually donate and serve the evening meal. Thank you on behalf of our clients, our staff, our volunteers and the Friends!"
